Successful IFDM 2010 in Los Angeles Paves Way for IFDM 2012 in London



The recent IFDM 2010 in Los Angeles in September – the fifth since the biennial International Forum in Disability Management (IFDM) was launched in 2002 – was a resounding success providing valuable networking opportunities for the more than 400 registered delegates from 34 countries who attended and benefited from the leading edge initiatives that were presented regarding disability management programs, policies and research. With an overwhelming response to the Call for Papers, the task of including as many presentations as possible within a structured framework during the two-and-one-half day event was a dilemma that most conference organizers would envy.

Chair of IFDM 2010 Christine Baker was enthusiastic about the response to this year's Forum: "California was so pleased to host the IFDM 2010. The issue of disability management and how to improve return to work resonated from prominent national specialists in disability management across the world; it was a truly collaborative event."

While there were many excellence presentations, of particular note were the plenary remarks by Dame Carol Black, Britain's Director for Health and Work. Her presentation, "Maximising the Health and Well-Being of the Working-age Population" emphasized the need for government collaboration, building consensus, facilitating change, and increasing awareness and support to create successful disability management and return to work outcomes.

Building on the successful IFDMs held in Canada in 2002, the Netherlands in 2004, Australia in 2006, Germany in 2008 and Los Angeles in 2010, the torch has now been transferred to the Royal Society of Medicine in the United Kingdom, which together with Unum and a national / international advisory committee will organize IFDM 2012, which will take place in London, England September 10-12, 2012.
